British Columbia Utilities Commission (BCUC) Order G-180-25 – Public Notice Confirmation Compliance Filing

On July 22, 2025, the BCUC issued Order G-180-25 establishing a regulatory timetable for the above noted proceeding, directing FBC as follows: make the Application and order available on its website,<sup>1</sup> provide a copy of the Application and order to registered interveners in the FortisBC Rate Setting Framework for 2025 through 2027 (Rate Framework) proceeding,<sup>2</sup> and provide notice of the Application and order on its existing social media platforms.<sup>3</sup>
