ORDER

WHEREAS:

- A. On March 18, 2025, the British Columbia Utilities Commission (BCUC) issued Order G-69-25 for FortisBC Energy Inc. (FEI) and Order G-70-25 for FortisBC Inc. (FBC) approving a Rate Setting Framework for 2025 through 2027 (Rate Framework Decision). In accordance with the Rate Framework Decision, FBC is to conduct an annual review process to set rates for each year (Annual Review);
- B. By letter dated June 10, 2026, FBC proposed a regulatory timetable for the 2027 Annual Review of Rates (FBC 2027 Annual Review) that includes FBC filing its Annual Review for 2027 Rates Application (Application), intervener registration, one round of information requests, and final and reply arguments; and
- C. The BCUC has reviewed FBC's proposal and considers that the following determinations are warranted.

NOW THEREFORE the BCUC orders as follows:

- 1. A regulatory timetable for the FBC 2027 Annual Review is established as set out in Appendix A to this order.
- 2. On or before Tuesday, August 4, 2026, FBC is directed to:
 - (i) Publish the Application and a copy of this order on its website at www.fortisbc.com;
 - (ii) Provide a copy of the Application and this order, electronically where possible, to all registered interveners in the FBC 2025 and 2026 Annual Review of Rates proceeding; and
 - (iii) Provide notice of the FBC 2027 Annual Review and this order on its existing social media platforms. Reminder notices must be published on each social media platform on a monthly basis during the

first week of each month until the conclusion of the letters of comment period on Thursday, September 24, 2026.

3. FBC is directed to provide to the BCUC:

- (i) By Thursday, August 6, 2026, written confirmation of compliance with the public notice requirements set out in Directive 2 of this order, except for the social media reminder posts, including a list of social media platforms on which the notice was posted and a list of parties notified; and
- (ii) By Thursday, September 10, 2026, confirmation of compliance with the public notice requirement set out in Directive 2 of this order regarding social media reminder posts.
