ORDER

WHEREAS:

- A. On March 4, 2019, the British Columbia Utilities Commission (BCUC) issued its decision by way of Order G-47-19 in the FortisBC Inc. (FBC) Application for Acceptance of 2019-2022 Demand Side Management (DSM) Expenditure Schedule proceeding, approving, among other things, FBC's request for funding transfers and carryover rules, subject to terms and conditions established in the order;
- B. On March 31, 2022, FBC filed an application for approval to carry over \$394 thousand in over expenditures from 2021 into 2022 (Application); and
- C. The Panel has commenced review of the Application and considers that establishing a written hearing process is warranted.

NOW THEREFORE the BCUC orders as follows:

- 1. A written hearing process is established for the review of the Application in accordance with the regulatory timetable as set out in Appendix A of this order.
- In accordance with the BCUC Rules of Practice and Procedure, interested stakeholders may submit a letter of comment by the date established in the attached regulatory timetable. Letters of comment must be in the Letter of Comment Form available on the BCUC's website at: <u>https://www.bcuc.com/forms/LetterOfComment</u>.

3. FBC is to notify registered interveners in the FBC 2019-2022 Demand Side Management Expenditure Schedule proceeding and members of the Energy Efficiency and Conservation Advisory Group of the opportunity to provide letters of comment on the Application in accordance with the regulatory timetable.
