Re: FortisBC Energy Inc. (FEI or the Company)

Application for a Certificate of Public Convenience and Necessity (CPCN) for the Tilbury Liquefied Natural Gas (LNG) Storage Expansion (TLSE) Project (Application)
FEI Request for Amended Regulatory Timetable

FEI writes to acknowledge the letter (Exhibit C6-7) dated June 11, 2021, filed by Sentinel Energy Management Inc. (Sentinel) requesting an extension to the timetable set out in British Columbia Utilities Commission (BCUC) Order G-165-21 for the filing of intervener information requests (IRs).

While FEI wishes to proceed with the regulatory review of the Application as soon as possible, we acknowledge the slight delay to providing Sentinel with the security-sensitive information pursuant to Mr. Langley's signed Non-Disclosure Agreement and Undertaking. As such, FEI does not object to Sentinel's extension request, and has set out below a proposed revised timetable that would accommodate it.

Given that the BCUC staff have had full access to the Application since it was filed on December 29, 2020, FEI believes it would be procedurally efficient for the BCUC to file their IRs based on the current schedule. The larger gap between BCUC and intervener IR No. 1 contemplated in the revised timetable below, while not typical, will give interveners additional time to consider the content of the BCUC IRs and remove any duplicative questions that may otherwise have been included. FEI believes this will result in a more clear and concise proceeding record.

The proposed amended timetable below also gives consideration to the other regulatory proceedings underway, which involve many of the same key FEI personnel and interveners, and the availability of FEI personnel.
