**FEI Request for Amended Regulatory Timetable**

FEI writes to request an amendment to the regulatory timetable established in British Columbia Utilities Commission (BCUC) Order G-95-22 to accommodate FEI's filing of an evidentiary update to the Application.

FEI requires an extension of three business days in order to finalize its evidentiary update, from the current filing date of Thursday, June 30 to filing on Wednesday, July 6.
