**Re: FortisBC Energy Inc. (FEI)
2022 Long Term Gas Resource Plan (LTGRP)
British Columbia Utilities Commission (BCUC) Order G-146-22 Compliance
Filing – Public Notice Confirmation**

On December 21, 2021, FEI filed the LTGRP referenced above. On May 31, 2022, the BCUC issued Order G-146-22 (Order) establishing a regulatory timetable for review of the LTGRP, directing FEI to provide notice as follows: provide a copy of the Order to various parties,¹ publish the Public Notice in display-ad format in appropriate news publications by no later than Friday, July 8, 2022,² post information regarding the Public Notice on social media platforms,³ and make the LTGRP and the Order available on its website.⁴

FEI confirms that the notice requirements under Directives 2, 3, 4 and 6 have been completed.
