Revised Renewable Gas Program Application – Stage 2 (Application)  
FEI Reply Comments on Final Argument Timetable**

FEI writes to provide its reply comments on intervener submissions as requested in British Columbia Utilities Commission (BCUC) letter dated April 4, 2023 (Exhibit A-47) with respect to FEI's request for an amendment to the regulatory timetable pertaining to Final Argument. FEI had proposed intervener written final argument be on Thursday, June 15, 2023 and FEI's reply argument on Thursday, July 6, 2023.

FEI is in receipt of submissions from the BC Sustainable Energy Association (BCSEA)<sup>1</sup> and the BC Old Age Pensioners' Organization, Active Support Against Poverty, Council of Senior Citizens' Organizations of BC, Disability Alliance BC, Tenants Resource and Advisory Centre, and Together Against Poverty Society (BCOAPO).<sup>2</sup>

The BCOAPO proposed moving the dates for intervener written final argument by one week to June 22, 2023 and for FEI's reply argument to July 13, 2023 to accommodate the availability of their expert consultants. The BCSEA had no objection to either FEI's proposed dates or the BCOAPO's proposed dates.

FEI has no objection to the BCOAPO's proposed timing resulting in the following proposed regulatory timetable for the Final Argument phase.
