**Re: FortisBC Energy Inc. (FEI)  
2022 Long Term Gas Resource Plan (LTGRP) – Project No. 1599324  
FEI Request for Timetable Amendment**

FEI writes to request a two-day extension to the filing deadline for its responses to round two information requests in the above noted proceeding from the current deadline of Monday, May 1, 2023 established in the British Columbia Utilities Commission (BCUC) Order G-17-23 to Wednesday, May 3, 2023.

FEI has been diligently working on its responses to the approximately 625 information requests it received and requires an additional two days to finalize its responses.

While this is a brief extension, to ensure that the regulatory timetable continues to reflect the balance of interests as previously determined by the BCUC, FEI proposes a commensurate two-day extension to the remainder of the actions in the regulatory timetable up to FEI's responses to IRs on rebuttal (if required). Therefore, FEI proposes the following amended regulatory timetable (the proposed changes are provided in red font for ease of reference).
