Re: FortisBC Energy Inc. (FEI) Application for a Certificate of Public Convenience and Necessity (CPCN) for the Okanagan Capacity Mitigation Project (OCMP or Project) (Application) Consultation and Communication Activities Update

FEI writes in accordance with the British Columbia Utilities Commission (BCUC) letter dated November 8, 2024 (Letter) in the above referenced proceeding.¹ In its Letter, the BCUC requested that FEI file an update with the BCUC detailing its consultation and communication activities, including the issues raised at the information session scheduled for November 25, 2024, and FEI's responses or planned follow up.

In Section 8 of the Application and in responses to information requests (IRs), FEI described its consultation and engagement activities undertaken leading up to the filing of the Application, and its plans for future consultation and engagement. In response to RCIA IR1 10.4, FEI also provided its consultation log.² FEI has updated the consultation log to include activities that have taken place since the response to RCIA IR1 10.4 was filed, including the November 25, 2024 information session (Appendix A to this letter). FEI has also provided its communications log (Appendix B to this letter), to describe FEI's promotion of the information session and accompanying media coverage.

With respect to the information session, 19 people attended with six individuals filling out a feedback form. Many of the comments on the feedback form thanked FEI for hosting and providing area residents with relevant information on the OCMP. FEI had numerous OCMP staff in attendance to ensure the public had opportunities for one-on-one conversations with subject matter experts. Most of the interactions were positive. Concerns raised included: aesthetics and visual screening; noise; traffic; safety; concern over the longer-term implications of advancing the OCMP instead of a pipeline option; and concerns over the emissions associated with natural gas usage. Below is a summary of the concerns, and FEI's response, including any commitments made.

Aesthetics

Some session attendees expressed concerns regarding aesthetic impacts of the OCMP, in particular visual impacts to the Project area. FEI responded that mitigation options for aesthetic impacts will be considered in the OCMP design and planning phase, specifically around visually screening the Project site from the street level along Spall Road. FEI intends to engage with area residents regarding visual screening options during the OCMP execution phase.

Noise

Some session attendees asked questions regarding potential increases in noise from the OCMP construction and operation. FEI responded that a baseline acoustic study will be conducted to better understand how the OCMP would impact noise levels at the Project area during facility operation, and that depending upon the study results, FEI may look at possible noise mitigation options, if needed.

Traffic

Some session attendees were concerned with traffic, in particular LNG fueling trailers turning into the proposed site. FEI noted that it will develop a traffic management plan for construction and operation; that during facility operations, the intention is for trucks to make deliveries during off-peak traffic times and during favorable weather for driving (autumn); and that there will be about 24 truckloads to the site per year (e.g., 3 trucks per day, for 8 days).

Safety

Some session attendees asked if the facility would have full-time personnel on site during normal operations. FEI said that the site will not be staffed on a full-time basis, but that the entire FEI system is monitored remotely, 24/7, and that FEI facilities around the province are monitored similarly. Additionally, FEI reinforced safety facts about LNG: that it is non-explosive and non-corrosive when stored; that in the unlikely occurrence of a leak, it dissipates to the air; that all structures will be built to the latest safety standards; and that the facility will include safety systems, such as fire and gas detection, to monitor for any potential risks.



Long Term Customer Value

Some session attendees expressed concern over the longer-term implications of advancing the OCMP instead of a pipeline option, including the implications on customer rates and affordability associated with advancing the OCMP and the potential requirement to build an additional project later, instead of advancing the original Okanagan Capacity Upgrade only.

Emissions from Natural Gas Usage

A representative from Kelowna Climate Coalition, a local climate advocacy group, expressed concerns about the emissions associated with the use of natural gas for home heating, the impact of these emissions on the province's and municipality's climate goals, and their preference towards electrification. FEI listened to the concerns and reinforced the work it is doing to decarbonize the use of gas, including advancing Renewable Natural Gas projects, investing in energy efficiency and conservation measures to reduce energy consumption, and complying with all municipal, provincial and federal (climate) laws.

Additionally, as stated on page 58 of the Application, FEI shared with session participants that it plans to:

Mitigate, manage and minimize potential short-term adverse effects and monitor Project impacts as construction proceeds. The mitigation measures will be based on industry best practices and applicable requirements of local regulations. To mitigate short-term adverse socio-economic impacts of Project construction, FEI will require the contractor to develop a Public Impact Mitigation Plan. Mitigation measures will include, for example, complying with municipal noise bylaws and limiting traffic access restrictions to businesses and residents during construction.

As described in the Application and in its Final Argument, FEI's consultation and engagement with stakeholders and Indigenous groups to date has been appropriate and reasonable, reflecting the OCMP's stage of development and schedule, and is sufficient to meet the requirements of the CPCN guidelines.

FEI's phased engagement plan for the OCMP calls for FEI to continue to consult with local stakeholder groups regarding the status of the OCMP after the issuance of a CPCN. FEI is committed to providing updates regarding the Project and proactively communicating with Indigenous groups and stakeholders to respond to issues or concerns throughout the Project lifecycle.³
