- The term "property" refers to the home occupied by an income-qualified tenant at the address listed at Part 2 (the "**Applicant**"), property information, of this Consent Form and meets the qualifications set out below.
- FortisBC reserves the right to, at any time, verify the accuracy and completeness of any and all information provided by the Landlord, and the
  Landlord must cooperate with this verification process. The Landlord must notify Energy Conservation Assistance Program (ECAP) Operations if
  any information provided as part of this application changes at any time after the submission of the application.
- The property must be a fully serviced existing residential building suitable for human habitation that is occupied on permanent year round basis (attached garages, outbuildings, buildings under construction, and unoccupied buildings are not eligible), and deemed to be in suitable condition for the improvements available through the program.
- FortisBC may without penalty or obligation, at its sole discretion, at any time, modify any terms or conditions or any of its requirements for program eligibility, and modify or terminate the program.
- FortisBC has the right to prioritize applications for program support within available funding based on any criteria deemed appropriate.
- The availability, timing, and amount of program support are subject to available program funding.
- FortisBC is not obligated to provide program support to any Applicants including those who meet all program eligibility criteria. It is within FortisBC's sole discretion to accept or reject any Applicant who meets all program eligibility criteria.
- FortisBC will decide in its sole discretion which improvements an approved Applicant will receive.
- This program is only for FortisBC and municipal utilities of Summerland, Penticton, Grand Forks and Nelson Hydro electricity customers and/or FortisBC natural gas customers. ECAP Program Applicants must also have a valid account.
- ECAP Program households (determined by service address) are not eligible to receive the program more than once every 10 years.
- Meeting all the criteria outlined on this form does not guarantee acceptance into the program.
- Services for Applicants in remote or hard-to-service locations and the timing thereof may vary.

## Landlord declaration and consent

- I certify that I am the legal owner or the Landlord of the property listed above and that I warrant that I have the authority to submit this Landlord Consent Form, and that I agree to these terms and conditions.
- If this application is approved, I grant permission for the program contractors to conduct a free energy-efficiency evaluation of the property and to install free basic energy-efficient products including but not limited to: compact fluorescent and LED lighting, weatherstripping, water-efficient shower heads, faucet aerators, pipe wrap and night light(s).
- If during the free energy-efficiency evaluation of the property contractors determine that the property qualifies for further upgrades, I hereby grant permission to FortisBC and FortisBC contractors to conduct an advanced assessment on the property.
- FortisBC, not being the designer, manufacturer, provider or installer of the products and/or improvements, make no representations or warranties whatsoever as to the fitness of, the necessity for, the quality of, or the energy efficiency/savings of, any product, improvement or service, or skill of any contractor. The Landlord does hereby indemnify and save harmless FortisBC and its affiliates, and its respective directors, officers, agents, contractors and employees, from all liability, damages, claims, demands, expenses and costs for claims, costs for injury or death of any person (including from any infectious disease outbreaks), damage to or destruction of property, and all economic loss suffered by any person (collectively, "Losses") arising from or occurring by reason of the Applicant's participation in the Program and/or the implementation of any Program recommendations, including the installation and/or use of recommended products and improvements. The Landlord irrevocably waives any and all claims against, and irrevocably releases and agrees not to sue FortisBC, its affiliates or and any of its respective officers, directors, employees, agents, contractors or representatives for and against all Losses arising from the Applicant's participation in the Program and/or the Program and/or the implementation of any Program recommendations, including the installation and/or use of recommended products and any of its respective officers, directors, employees, agents, contractors or representatives for and against all Losses arising from the Applicant's participation in the Program and/or the implementation of any Program recommendations, including the installation and/or use of recommended products and improvements.
