

# Connect to Gas and Wall Furnace Program Bonus Offer Terms and Conditions



## BONUS REBATES OFFER

For a limited time, FortisBC Energy Inc. (“**FortisBC**”) is offering bonus rebates (the “**Bonus Offer**”) as part of the Connect to Gas and Wall Furnace rebate program (the “**Program**”). FortisBC customers who, in addition to meeting all of the criteria set out in the Program terms and conditions available at [fortisbc.com/connecttogas](https://fortisbc.com/connecttogas) and [fortisbc.com/wallfurnace](https://fortisbc.com/wallfurnace) (the “**Program Terms and Conditions**”), meet all of the criteria of the Bonus Offer as set out below (the “**Bonus Offer Terms and Conditions**”) may be eligible to receive a bonus rebate:

1. **Pre-qualification:** FortisBC customers who are eligible for the Program rebate(s) (the “**Customer**”) must (i) complete the pre-qualification form on [fortisbc.com/connecttogas](https://fortisbc.com/connecttogas) or on [fortisbc.com/wallfurnace](https://fortisbc.com/wallfurnace) (the “**Form**”); (ii) obtain a promotional pre-qualification code (the “**Pre-Qualification Code**”) between October 1, 2022, and March 31, 2024; and (iii) submit the Program rebate application pursuant to section 0 of these Bonus Offer Terms and Conditions to be eligible for the Bonus Offer. Only Pre-Qualification Codes that begin with “22b1y” may qualify for the Bonus Offer. No other pre-qualification codes or promo codes qualify for the Bonus Offer.
2. **Term and completion of Bonus Offer work:** The Bonus Offer is available for Customers who have obtained a promotional Pre-Qualification Code between October 1, 2022, and March 31, 2024 and who between October 1, 2022, and June 30, 2024 (i) have installed a Heating System or Heating and Hot Water System in their residence, which must be in FortisBC’s natural gas or propane service territory, and are converting their primary residential home Heating System from wood, oil or propane to natural gas; or (ii) have installed a new Wall Furnace or Wall Furnace and Hot Water System in their residence, which must be in FortisBC’s natural gas or propane service territory. Invoices must be dated October 1, 2022, or later, but no later than June 30, 2024.
3. **Eligible rebates:** Customers must meet the Bonus Offer Terms and Conditions and Program Terms and Conditions to be eligible for the Bonus Offer. Both Bonus Offer Terms and Conditions and Program Terms and Conditions are available at:

FortisBC reserves the right to refuse applications or invoices that it determines, in its sole discretion, are incomplete, inaccurate or otherwise do not meet Bonus Offer Terms and Conditions. Where FortisBC exercises any right, discretion or decision-making, such exercise shall be in FortisBC’s sole, absolute and unfettered discretion.

4. **Bonus Offer rebate amounts and contractor incentives:** In addition to the rebate amounts set out in the Program Terms and Conditions:
  - i. Customers who qualify for the Bonus Offer may be eligible for the following Bonus Offer rebate amounts:
    - a) \$1,000 bonus rebate for a qualifying Heating System or Heating and Hot Water System; or
    - b) \$500 bonus rebate for a qualifying Wall Furnace or Wall Furnace and Hot Water System.
  - ii. Contractors who install a qualifying Heating System or Heating and Hot Water System or Wall Furnace or Wall Furnace and Hot Water System between October 1, 2022, and June 30, 2024, may be eligible for the following Bonus Offer Contractor incentives:
    - a) \$50 bonus incentive for installing a qualifying Heating System or Heating and Hot Water System or Wall Furnace or Wall Furnace and Hot Water System.

Contractor Bonus Offer incentive amounts will be determined based on whether the Customer received the Bonus Offer pursuant to the Bonus Offer Terms and Conditions. Contractor Bonus Offer incentive will only be paid upon FortisBC’s approval of the corresponding Customer Bonus Offer rebate.

5. **Application term:** To receive the Bonus Offer rebate, Customers must submit their Program rebate application, all supporting documents and invoices on or before the earlier of: (i) 90 days of the invoice date of the Heating System, or Heating and Hot Water System, or the Wall Furnace, or Wall Furnace and Hot Water System; and (ii) September 30, 2024. Applications must include the applicable Pre-Qualification Code. Applications submitted after September 30, 2024, will not be eligible for the Bonus Offer but may be eligible for the regular Program rebates subject to the Program Terms and Conditions.
6. **Funding:** Funding for the Bonus Offer is limited and will be paid on a “first come, first served” basis. Customers may be eligible for regular Program rebates after all funding for the Bonus Offer has been paid out. FortisBC may at its sole discretion decline to pay a Bonus Offer or Program rebate. A limited number of Pre-Qualification Codes are available. The Bonus Offer will be terminated once all of the available Pre-Qualification Codes for the Bonus Offer have been issued. FortisBC may amend, modify or terminate the Bonus Offer at any time based on funding limitations or for any other reason, without penalty, notice or obligation.
7. In these Bonus Offer Terms and Conditions, save as otherwise defined herein, capitalized words and expressions used shall have the same meanings as are respectively assigned to them in the Program Terms and Conditions.
